# 7.1 Ad Hoc Planning Committee – Steve Elson

Written report circulated.

- A wine and cheer reception will be held in the FSA Atrium on May 8<sup>th</sup>. It is being called Arts after 5 and all the people invited to the October 4, 2017 roundtable on the Arts have been invited to come back and reconnect. Andrea Halwa, Executive Director of the London Arts Council will speak at the event.
- A design has been developed for the Garden Project and it will now be translated into specifications that can be used by a landscaping firm. The project has been divided into three phases. The initial phase will include a staging area near the front entrance, a labyrinth, and an Indigenous medicine garden. Phase 1 will be implemented in the summer and fall of 2018.
- On April 4<sup>th</sup> the Planning Committee welcomed representatives from 12 United Church congregations from Middlesex Presbytery to a roundtable focused on nurturing spiritual growth. An invitation to a follow-up meeting to plan collaboration opportunities will be sent out.
- The Planning Committee is considering how to use the approach of Appreciative Inquiry to identify and build on what is positive at FSA.

Financial statements for January, February and March 2018 were distributed.

A Standard Operating Procedure regarding the logistics of how money is collected at events and then is counted was circulated. This SOP covers worship collection, ticket sales, sales of merchandise (including gift cards), and money collected at fundraisers. The SOP has been reviewed by the Finance Committee and a note will be sent to church committees and groups regarding cash handling procedures.

A Standard Operating Procedure is in place which gives the Finance Committee responsibility for reviewing and approving new fundraising initiatives. The goal is for all fundraisers to be successful. George Jolink and Heather Vouvalidis are tracking fundraising projects occurring in 2018. Council will discuss the results of this review.

The Finance Committee is researching database solutions for FSA. Council was reminded that the United Church of Canada is moving to a Three Council Governance Model in January 2019

which will have 16 regional councils. The regional council may recommend what database its member churches use.

### 9.4 Electronic Sign Project

The Property Committee had been working on raising funds for an exterior electronic LED sign. Unfortunately, we have learned of a change to the City of London bylaws (passed May 2017) that prohibits illuminated electronic signage in the Historic West Woodfield Heritage District. The Property Committee recommends that money raised for this project (approximately \$9,000) be redirected to another capital project. Projects being considered are: projection in the sanctuary, electronic messaging for the Atrium entrance, and the community garden project.

The Property Committee was asked to consider the installation of a stair lift for the stairs leading from the Narthex to the balcony.
